Re: Agreement with the Sno-Isle/ Everett Community College CTE Dual Credit Consortium

Attached is a copy of the CTE Dual Credit Agreement between the Sno-Isle/ Everett Community College Dual Credit Consortium and the Stanwood-Camano School District. This is an ongoing agreement that has been renewed annually and greatly benefits the students in our district. The new version of the agreement has shifted to a 3-year renewal period.

Through the CTE Dual Credit program, students in Career and Technical Education programs are able to earn college credit at Everett Community College. These credits can be used for further study at EvCC or transferred to any school the student may attend. The credits are transcribed on the EvCC transcript as a college level course. Currently we offer 14 CTE Dual Credit courses at Stanwood High School.

In 2018-19 a total of 232 students from Stanwood High School earned 1261 credits through this program. This was an increase from the previous year of 36 students and 281 credits.

2019 - 2022 Memorandum of Agreement Sno-Isle/Everett Community College Consortium

The Sno-Isle/Everett Community College CTE Dual Credit Consortium is a partnership of business, labor, community, and education that meets common regional needs by preparing students to successfully advance from high school through postsecondary education into the world of work. Membership includes the following college and school district partners: **Everett Community College, Arlington School District, Darrington School District, Edmonds School District, Everett Public Schools, Granite Falls School District, Lake Stevens School District, Lakewood School District, Marysville School District, Monroe School District, Mukilteo School District, Quillayute Valley School District (Insight School of Washington), Snohomish School District, Snohomish School District, Sno-Isle Skills Center, Stanwood-Camano School District, Sultan School District, Washington Center for Innovative Careers (WaNIC) and Omak School District (WAVA Washington Virtual Academy).**

CTE Dual Credit agreements are designed to award college credit to students who successfully complete articulated college level career and technical education courses and programs while still in high school. RCW 28B.50.530 authorizes community and technical colleges to establish agreements in collaboration with local school districts. Articulation agreements define the criteria for equivalency and the granting of credit. The following guidelines provide a framework and operational structure for colleges and school districts to facilitate the implementation of articulation through direct transcription.

Purpose

The purpose of this articulation agreement is to enable students completing high school career and technical education programs to earn college equivalent credit for courses taken as part of their secondary education program. Each program covered under this agreement will have an articulation agreement signed by the college and school district designees from each participating institution. An articulation agreement is designed to provide students with a non-duplicative, coherent, sequence of progressive achievement leading to technical skill proficiency, a credential, a certificate, or a degree.

I. Provisions

Maintaining college standards is important to the overall strength of a dual credit course. In an effort to prepare students who will be educationally competitive, the same rigorous college standards will be applied to all dual credit courses irrespective of where or how the instruction is delivered. High school faculty teaching the dual credit course(s) will provide instruction to support the competencies listed in the articulation agreement.

College Partners Will:

- Establish the course requirements for college credit to be granted. Course competencies identify the academic and technical skills for each course and may include requirements such as term papers, portfolios, or industry certification exams. Students must achieve a C (2.0 – 70%) or better grade in the course competencies to qualify for college credit.
- Identify the articulated course on the transcript as a regular college-level course. No designation will be used to indicate the course was taken while the student was in high school.
- At the discretion of the college division program chair, a student failing to make satisfactory progress in a college course or a college program of study may be required to retake a college course that the student had previously earned credit for through the high school CTE Dual Credit program.

District Partners Will:

- Ensure all College CTE Dual Credit articulated courses are taught by instructors who meet the WA State CTE teaching requirements or meet employment criteria. *WAC 131-16-095 (2)*
- Ensure the high school program/courses meet the academic and technical standards established for career and technical education (CTE) state approved programs.
- Identify an administrative point of contact (principal/CTE director) to ensure instructor compliance with the articulation agreement.
- Ensure student compliance with college enrollment policy to avoid duplication of courses and credits.

Students Served: The college and school district partners will make reasonable efforts to ensure all student populations are served by the CTE Dual Credit program.

Program Fee: Beginning academic year, 2019/2020, Everett Community College's (EvCC) Career and Technical Education (CTE) Dual Credit program will begin charging \$50 per student, per year. The funds will be applied to the College's overhead for administering the CTE Dual Credit program. The \$50.00 fee will be waived for students in the WA State Free & Reduced Lunch program and Foster or McKinney Vento status

youth. The School can pay the fee directly to the College. The school must send EvCC a list of students receiving class credit, to the CTE Dual Credit manager, by the last day of the school year, including those students in the WA State Free & Reduced Lunch and Foster or McKinney Vento status youth program requesting transcription. OR The student can pay the fee directly to the College at the end of the school year or up to three years after their high school graduation. However, it is essential that the student has registered for their class(es) in SERS and has received a grade of "C" or better for the year(s) they want their credits transcribed. No exceptions. If a student had received free and reduced lunch during any period in high school, they would need to provide documentation to the CTE Dual Credit manager prior to requesting transcription.

Data Collection: All partners agree to assist in the collection of data concerning student participation, student performance, and instructor participation in the CTE Dual Credit program. Data will be used to determine the success of students who receive articulated credit during high school and then transfer to college in the same or similar pathway program.

Grades: A "C" instead of a "B" will be considered as a passing grade and eligible for transcription.

Each District and/or CTE Director agrees to ensure that student grades are submitted in a timely manner once the academic year concludes. Grades that are not submitted through the SERS grading module may subject a student to lose any college credits they may have been entitled to earn through the CTE Dual Credit program. The College and CTE Dual Credit staff will not be responsible for entering grades for students.

Agreement Revision/Renewal: As required by law, this agreement will be reviewed regularly and approved by the lead administrators (college presidents and school district superintendents or designee) of the educational partners. (Perkins 2006, SEC. 3)

Credit Transfer: College credits, including those awarded through direct transcription, may or may not transfer to four-year institutions or other colleges outside the state's community/technical college system. It is the responsibility of the student to consult with those institutions concerning specific credit transfer and admissions requirements.

Agreement Termination: This contract is valid for a period of 3 years. Commencing on September 1, 2019 to August 31, 2022. Individual school districts and/or college partners may terminate this agreement without cause by giving 90 days written notice. If Everett Community College terminates participation in the CTE Dual Credit program, the college will continue to honor CTE college credits for students currently enrolled in articulated courses at the secondary school and registered to earn college credit at the end of the term.

II. Procedural Steps in the Agreement Process:

1. Students must be enrolled in an approved CTE Dual Credit articulated course or program of study.
2. Students must register for dual credit using the consortium’s registration process and specified timeline.
3. Students must register to earn credit at only one college when the same high school course is articulated at multiple colleges within the consortium.
4. Participating high school instructors will use the consortium’s registration/grading process to enter grades and verify student completion of articulated courses during the specified timeline.
5. Students will receive college credit upon successful completion of the dual credit course(s) with a grade “C” (2.0 – 70%) or better and payment of CTE Dual Credit Fee.
6. Transcripts will be made available to students once processing and reporting have been completed, usually by the end of summer.
